## Completing the GAP Pre-Proposal

The GAP pre-proposal is a short preliminary application (2-3 pages maximum) to outline the details of an FSU project to be considered for inclusion in the GAP program.

Once this pre-proposal is completed by filling out the document below, it will be evaluated by a group of business professionals who will assess the application's commercial merit to determine acceptance for the next round of GAP. This application is straight forward and should take a short time to complete. Before you complete this application, please review the SAMPLE pre-proposal that is available in the GAP Program Guide, found on the GAP webpage at <http://research.fsu.edu/research-offices/fsu-research-foundation/grants/gap-grant/>.
